### *Career*

Professor Cornelia Lefter has two university degrees, an B.A. in economics from the Bucharest University of Economic Studies (ASE) in 1977 and a J.D in law from the University of Bucharest, Faculty of Law in 1985. Then, she completed her high education in 1992 with Ph.D degree in law at University of Bucharest, Faculty of law, with specialization in trade law and European Union Law. Considering that education is a continuous process, she attended different training stages in comparative trade law and European Union law in France (September 1991- February 1992 at University of Toulouse; April-June 1993 at Orleans University, Faculty of Law, Economics and Management; February-March 1997 at Conservatoire National des Art et Metires, Paris ; March-April 2000 at Orleans University, Faculty of Law, Economics and management), in Nederland (February-March 1993 at European Institute of Public Administration, Maastricht), in USA (September 1994-April 1995, Fulbright grant at Indiana University, School of Business, Bloomington), in Canada (October 1999-February 2000, at Universite du Quebec a Montreal) and in England (September - October 2001 at Reading University, Faculty of Law). Since 1997 she held the position of professor at the Law Department of ASE where she teaches for the Faculty of Business Administration with teaching programs in foreign languages (FABIZ) courses in English and in French. She also teaches in Master programs organized by the ASE and by the University of Bucharest, Faculty of Law. Prof. Cornelia Lefter was for 10 years (2001-2011) associate professor in France, at Orleans University, Faculty of Law, Economics and Management where she taught within the second year of Master courses of Comparative trade law and European Business law. Since 2012 she is associate professor in France, at Strasbourg University, School of Business. Along with her teaching activities she coordinates graduation papers and master dissertations papers. From 1999 she also coordinates Ph.D thesis in trade law and European Union Law. Taking into account that teaching of law is a difficult task unless it is grounded on practical experience, Prof. Cornelia Lefter uses her practical knowledge as member of the Bucharest Bar Association (since 1991) and lawyer with private law office (since 1997). She added to her practical skills her experience as arbitrator at the International Commercial Arbitration Court of Romania (since 2004) and mediator (since 2012). She has also a great experience in EU programs after working for the European Commission (1997-2002) in 6 programs as a national expert. To complete her complex profile as professor at high education level there have to be also mentioned her publishing achievements (12 books - 2 of them in English; over 27 articles in reviews listed in international databases, over 35 studies presented in international and national conferences and one study published on OECD website) and her administrative positions as vice-dean of FABIZ (A.S.E), or member of CNRED (within the Ministry of Education) or of CNCIS and expert within ARACIS.
